7 CAT and Grants – update

 ${\bf CAT}$ - ${\bf GR}$ is meeting with the Scottish Civic Trust on Friday 25^{th} June and there will be a meeting with the Council on Friday 2^{nd} July. LR has offered to start writing the Business Plan and seeks all the financial information held by other committee members.

The discussion spread to the wider matter of the unkempt state of the Outer and Inner Courtyards created by the restaurant. This is especially concerning as STA will be using the Outer Courtyard for a number of events over the summer. CT has spoken to the restaurant and is hopefully that some action is forthcoming. CC will contact the Council to establish what powers the latter has and whether they are willing to use them.

Grants - There are two outstanding grants at the moment. Firstly the Coastal Community Fund. DC is working on the final stages of the 'Peebles' book. Unfortunately production has been hindered by too many potential contributors and DC will slim down the numbers participating in preparation for producing a final version of the book.

The second grant has been provided by Museum Galleries Scotland (MGS). DCu has negotiated an extension of the deadline to 30th July and all of the project objectives are in place for completion by this new deadline:

- This Little Piggy (TLP) is providing social media training and DCu is in discussion concerning the production of a video. Invoice expected shortly.
- Mearns FM have tendered for a two month advertising campaign and the committee accepted the proposal.
- The outreach equipment has been purchased.
- DCu has a proposal for a number of small booklets with a tear page for volunteer applications.

8 Events report (CT/MS)

On Saturday there will be a Story Telling event in the Courtyard and this will be combined with a display of the entries (30/40 in total) for the Children's Art Competition. On 10th July IB will hold a demonstration on net making and this may be combined with the building of a fireball.
