Savannah (Over 50's Club) inquired about a museum member providing a talk on Stonehaven witches. This is not a topic on which the museum has any expertise and Amy Calderwood suggested referring the Club to the Elphinstone Institute.

### 6 Secretary's report (AN)

Electrical work to rectify identified faults will be undertaken on Tuesday 24<sup>th</sup> September; AN in attendance.

The bi-annual fire alarm safety check is due in September.

The annual footfall is running about 7% below the corresponding figure for 2023. This can be attributed to the poor weather in April and May which severely curtailed visitor activity; however, the annual foot fall is still predicted to be about 18,000.

There is a possibility of a visit from members of the Kent Geological Society latest this month. The 'Stonehaven' mangle which was located outside the museum had decayed to the extent that it was in a dangerous condition and is now in the Outer Courtyard. There is a possibility that the Men's Shed could re-novate the item. Discussions will be held.

### **7 CAT and Grants**

**CAT.** After many months (years?) the Council has finally issued a Decision Notice in which they have offered to sell the ground floor and courtyards to STA for £1. STA has until the 28<sup>th</sup> September to appeal against the decision and until 31<sup>st</sup> January 2025 to make a firm offer for the property as outlined in the Decision Notice. A special trustee meeting will be held on 25<sup>th</sup> September to consider appealing.

**Grant**. At the same time that the Council issued the Decision Notice they sent a Letter of Comfort to the Coastal Community Challenge Fund (CCCF) stating that a CAT had been offered and they had no objections to the paving of the Inner Courtyard. Based on this letter CCCF have released accessed to a grant. AN had an onsite visit with the construction company and John Aitken (project manager) on Tuesday 3<sup>rd</sup> and work should commence on 11<sup>th</sup> September, labour availability permitting. The planning department has been notified on the start date.

The trustees were informed that there are further contracts pending concerning the Tolbooth building:

- a) To be run by the Council and mainly concerned with the roof and external walls although, additionally, fire and sound barriers are to be installed between the museum and the restaurant
- b) Repairs to be paid by the restaurant. Currently STA has not been notified about the extent of these repairs

Pauline Cordiner has offered to hold a Halloween themed event of Saturday 26<sup>th</sup> October. CT is liaising with Pauline.

The last Globus visit will be on  $2^{nd}$  October. The committee consider these visits successful and delegated CT to hold negotiations on the potential of visits in 2025

Quiz Night at the British Legion is on Friday 25<sup>th</sup> October.

# 11 Shop report (LR)

The order from Glen Appin has finally arrived after a long delay. A few new items are being trialled e.g., hair scrunchies. AN asked whether we catered sufficiently for males and LR pointed out the availability of shot glasses, hipflasks etc.

LR has met with Anna Ross (Frost Pocket Press). The latter has acquired a number of printer's blocks from James A Bruce and had suggested that there was merit in creating postcards from the blocks. LR, and the committee, felt that postcards are out of fashion but other usages of the blocks deserved to be explored. Discussions will continue.

## 12 Clock Tower report (AN)

We get occasional reports of the main video not working in the Tower and there appears to be an intermittent fault in the software. However, switching the device on and off a couple of times seems to 'kick' the device into action.

### **13 AOCB.**

Younger members/trustees. LR raised the on-going difficulty of attracting younger members. There is no easy solution to this problem but she will include the wish to attract 'fresh blood' in the social message announcement of the AGM. Also trustees should consider making informal approaches to any potential candidates in the local community.

Museums Association. At the last meeting LP mentioned the Museums Association (MA) organisation. This discussion triggered a distant memory with AN and subsequent research shows that STA joined the MA in 2013 with the museum being listed on their website- the listing is still there. However, all contact details for the website have been lost. In a recent conversation with MA the latter suggested that we should re-apply at a cost of £84 per annum. Both AN and DC failed in see any benefit in re-joining and recommended not to proceed. The committee concurred.
